

Terms of Reference (TOR): Consultancy to develop Information, Education, and Communication (IEC) Materials.

About NTA.

Through promoting robust public finance systems, the initiative ensures access to critical services such as healthcare, education, and water while holding duty bearers accountable for delivering on their mandates.

This project is a social and economic justice catalyst, fostering a governance ecosystem where transparency, inclusivity, and fairness become the norm.

Purpose of the Consultancy

The purpose of this consultancy is to develop tailored Information, Education, and Communication (IEC) materials specifically focused on local-level governance and public participation, with an emphasis on the Nandi Equitable Development Act. These materials will aim to enhance public awareness and understanding of governance structures, policy frameworks, and public finance management processes at the grassroots level.

Scope of Work

- Designing IEC material such as posters, and other print materials.
- ➤ Incorporating illustrations and cartoons to make the content engaging and accessible to the target audience.
- > Revising and refining the designs based on feedback from project stakeholders.

Deliverables

- Final designs of IEC material including posters, etc.
- Source files and copyrights for all designs.

Duration of the Contract

The consultancy is expected to take **5 days** from the date the contract is signed.

Remuneration/Consultancy Fees

The consultancy fees shall be as agreed with the consultant based on the best value for money. The consultancy fees shall be inclusive of statutory tax deductions. Payable EFT transfer.

Qualifications:

The consultant should possess the following qualifications:

- Demonstrated experience in graphic design, particularly in the development of IEC material for development projects.
- ➤ Proficiency in using design software such as Adobe Creative Suite (Illustrator, Photoshop, InDesign).
- > Strong understanding of communication principles and the ability to translate complex information into visually appealing designs.
- ➤ Experience working on projects related to accountability, transparency, or social development is preferred.

Reporting

The consultant shall report to the Project Officer.

Interested consultants are invited to submit their proposals including:

- ➤ A brief overview of relevant experience and qualifications.
- > Samples of previous work demonstrating proficiency in graphic design and development of IEC material.
- Proposed approach and methodology for the consultancy.
- Detailed budget.
